The fee of the school was fixed vide the above-referred order. A review application has been filed by the school management on 30.01.2025 seeking an enhancement of the fee structure by 10% over and above the fee fixed by the Committee vide order dated 11.12.2024, whereas this Committee has approved an enhancement of only 5% in average. The School is running in deficit of Rs.31.15 lakhs. In order to compensate deficit amount the review application is allowed with below mentioned proposed revision.

**Revision:**

Tuition Fee: 3% hike in Tuition Fee over and above fee fixed vide order dated: 11.12.2024 and one time annual fee @Rs.8000/-, Rs.9000/- and Rs.10000/- for the sessions 2024-25, 2025-26 and 2026-27 respectively.
